# The Campus

The Institute of Law is located on the picturesque Nirma University campus, situated on the Sarkhej-Gandhinagar Highway. Spanning over one hundred and twenty acres, this campus provides an ideal environment that stimulates intellectual alertness and creativity. The green, energy-efficient, and Wi-Fi-enabled campus is designed to meet the academic and co-curricular needs of the students.

Nirma University campus offers a gymnasium and playgrounds for students' recreational activities and sports events. The campus canteens and cafeterias provide hygienic and healthy vegetarian food. Additionally, Nirma University has efficient healthcare services on campus, catering to the physical and mental wellness of students and employees. A well-organized transport service is also in place to facilitate effortless daily commuting.

## Ensuring Students' Safety and Wellbeing on the Campus

The measures taken by the Institute of Law to ensure the security of the students and employees on the campus are manifold. The campus is an alcohol and tobacco-free zone, with guards and surveillance cameras ensuring round-the-clock security. The hostels offer safe and comfortable residential facilities under the supervision of wardens and the faculty-in-charge. Students can discuss their problems and concerns with their assigned faculty mentors who conduct regular formal and informal meetings and are accessible by phone and email.

Institute of Law follows a zero-tolerance policy towards ragging and sexual harassment under the policies adopted by Nirma University. The Institute has an Anti-Ragging Committee and an Anti-Ragging Squad to ensure compliance with the relevant legal regulations and to prevent ragging on the campus and hostels. The students are regularly sensitised on the norms concerning what constitutes ragging and how to seek redressal. Members of the faculty make frequent visits to the hostels and talk to the students to find out whether there are any incidents of ragging. Similarly, events focusing on the prevention of sexual discrimination and harassment are organised from time to time to generate awareness among the students, faculty, and staff. Nirma University has a rigorous system in place for the prevention, prohibition, and redressal of sexual harassment.

## Pedagogy

Institute of Law relies on a combination of pedagogical tools to provide the students with an efficient and scientific learning environment. The teaching/learning strategy targets the expansion of knowledge, skills, and aptitudes in a manner that leads to tangible outcomes. The courses offered aim at a holistic development of the cognitive, critical, creative, and practical abilities of the students. Evaluation methods are designed with a view of perceptively assessing the learning outcomes and skills acquired.

The students and members of the faculty publish regularly on such diverse platforms as blogs, newspapers, magazines, and journals. The Institute of Law has identified significant domains of interdisciplinary knowledge relevant to legal studies and continues to explore these interfaces through its academic events and publications.

The Academic Research Centres under the supervision of faculty members with proven erudition and proficiency in each of these domains of knowledge facilitate rigorous learning and research. Further, there is an emphasis on the practical aspects of theory wherein students apply their conceptual knowledge to legal issues and problems. To enable the students to gain a better insight into the workings of the legal profession, a practical work component has been added to all the courses.

# Corporate Interaction and Industry Exposure

The Campus Recruitment Cell (CRC) derives its motivation and vigour from the confidence that students have in its capabilities. Serving as a bridge between potential employers and students, the CRC plays a crucial role in the recruitment process. Both students and faculty, in collaboration with Managers of Corporate Relations, participate actively in facilitating placements. The Committee is committed to maintaining a transparent, reliable, and responsible connection between prospective employers and students. It is attuned to the requirements of both students and the job market, striving to meet the expectations of both parties effectively.

## Objectives:

- 1. Job Placement and Internships:** To secure job opportunities and internships for students.
- 2. Industry Collaboration:** To build and maintain relationships with various companies for recruitment and collaborations on academic fronts.
- 3. Skill Development:** To enhance students' employability through training programs, workshops, and seminars.
- 4. Alumni Relations:** To develop a strong network to facilitate guest lectures, sessions, jobs, and internships by our Alumni

## New Initiative by Campus Recruitment Cell

- Mock Interview and Counselling Sessions:** To give a preview and a realistic simulation of how an actual interview with potential employers is, One-to-One Mock sessions are organised for the pre-final year which specially focus on each student's area of interest and competence. These interviews are followed up by an individual feedback and counselling session.
- Professional and Academic Competency Test (PACT):** A very unique program for final year where students are evaluated on the core five subjects of law; Constitutional Law, Criminal Law, Contract Law, Corporate Law, and Intellectual Property Rights. The students face a panel of four experts who evaluate students based on the above five subjects and suggest the best suitable career options for the candidate. Through this programme, the students are also able to focus on the subjects they are weaker in and the Institute can also undertake workshops, trainings, and sessions on the subjects that are suggested by the panel members.

# Beyond the Classroom

Institute of Law believes that while sound academic scholarship and research exposure are important, students need manifold opportunities for honing their skills. ### B. Eligibility

A candidate should have passed Higher Secondary/Intermediate Examinations (10+2) or its equivalent examinations with not less than 45% aggregate marks. Candidates who are appearing in the qualifying examination in May 2025 are also eligible for applying to the Institute. However, they shall be required to produce evidence of their passing the qualifying examination at the time of admission.

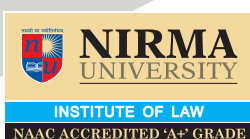
